



#### **1.** Organization of the Public Sector

- Federal (National) Government
  - Constitutional protections for private land ownership
  - \$ and Oversight
- State of Pennsylvania
  - Sector-specific laws (ie, environmental, transportation, housing, etc.)
  - \$ and Oversight
- Regional Delaware Valley Regional Planning Commission (DVRPC)
  - \$ and Transportation Coordination
- City of Philadelphia
  - Primary responsibility for city planning

#### 2. Private Sector Functions

- Developers
  - Assess feasibility (profit potential/RISK)
  - Gain ownership
  - Design/Engineer the project layout/structures
  - Bid/oversee construction
  - Market property (rent/sell)
- Investors
  - Assess feasibility/Lend \$
- Designers/Engineers
- Builders
  - Hire/train/licensed construction workers, then construct
- Legal


#### 3. Working together to achieve the "Public Good"

- Public Sector planning functions that <u>support</u> market development
  - Creating a shared vision citizens/government/businesses/NGOs
  - Providing a shared base of information
  - Strategizing plans and regulations
  - Advocating
  - Reducing risk
  - Prioritizing investment

- Local government is more <u>responsive</u> to citizens' everyday needs
- but, <u>oversight</u> is needed (external, internal, public)

  - Commerce (land, capital, infrastructure, education, institutions)



- **1. PHILADELPHIA** CITY PLANNING COMMISSION
  - Comprehensive/Strategic Planning https://www.phila.gov/programs/the-comprehensive-plan/

Develops the City's Comprehensive Vision and District Plans, and various Strategic Plans, ie, Waterfront Plans, Downtown Plan, etc.

- <u>Not</u> Master Planning
- <u>Required</u> for zoning and other development controls
- Sets <u>patterns</u> of land use and development that are functional and "market oriented"



- **1. PHILADELPHIA** CITY PLANNING COMMISSION
  - Community Planning
    - Acts as the development liaison with 200+ neighborhood associations
    - Organizes direct and constant input and review from the public
    - Collects and shares base information at the neighborhood level
    - Works with the public to formulate preliminary recommendations
    - Ensures fair and open public discussion of planning issues

PCPC has five primary responsibilities:

- assess department requests
- assign appropriate financial sources within mandated limits
- accommodate mayoral and council priorities
- incorporate citizen input
- set funding priorities

Projects are evaluated within revenue categories by the criteria below for priority funding:

#### **1. PHILADELPHIA** CITY PLANNING COMMISSION

• The Zoning and Subdivision Code

The Philadelphia *City Planning Commission* is responsible for:

- Developing and updating zoning maps and categories
- Conducting the official zoning review of developer proposals
- Reviewing and advising the ZBA and City Council on zoning updates and developer appeals

#### 2. ZONING BOARD OF ADJUSTMENT

The ZBA adjudicates zoning appeals

#### **3. ART COMMISSION**


The Art Commission reviews the designs of:

- Construction projects located on City property or funded with City money
- Anything constructed or installed on or over the public right-of-way

#### **4. HISTORICAL COMMISSION**

- Identifies/designates historic landmarks
- Maintains the Register of Historic Places
- Runs public meetings on historic properties
- Works with owners to protect landmarks



#### 5. DIVISION OF DEVELOPMENT SERVICES (DDS)

The DDS <u>facilitates</u> development by:

- Providing information about permits and approvals
- Answering questions, providing feedback, making connections with City departments, and advising on new or unique issues on complicated projects

## **D.** Philadelphia Building, Construction, Occupancy Code

• Administration – Department of Licenses and Inspections (DL&I) https://www.phila.gov/departments/department-of-licenses-and-inspections/

DL&I assists contractors, businesses, property owners, landlords, and tenants comply with building safety standards and code requirements

#### Responsibilities

- Issue trade, business and property licenses
- Review plans and issue construction and zoning permits
- Issue property use permits
- Inspect construction projects
- Respond to complaints regarding code violations

## D. Philadelphia Building, Construction, Occupancy Code

- Responsibility and Accountability Ensuring buildings are safe and functional
  - Licensing, permitting, and inspections are a <u>necessary but not sufficient</u> tool for full accountability
  - For full accountability, the <u>larger responsibility rests with the private</u> <u>sector</u>: the developers, engineering/architectural services, construction companies, lenders and insurers that together build and maintain the bulk of the physical environment
  - Their accountability results from their <u>understanding</u> that if something goes wrong they (whoever is proven to be at fault in a court of law) will be harshly penalized: under criminal law (if someone is killed or injured those responsible can go to jail), or civil law (the responsible party can be sued for substantial monetary damages)

# **E.** Accountability of Planning and Development

#### **1.** Need to Assess the Extent and Impact of the Lack of Accountability

- Areas of vulnerability
- Level of political will
- The cost and impact to residents and businesses
- The culture for change in the legal/institutional environment

#### 2. Strategize

- Develop an <u>Education</u> Program
  - Develop themes specific to Key Audiences, i.e., the general public, the media, government offices, etc.
  - Develop a long-term sustainable media approach

# **E.** Accountability of Planning and Development

#### 2. Strategize - continued

- Develop an <u>Prevention</u> Program
  - Code of Ethics
  - Public Complaints Office
  - Transparency & Accountability Structures, Systems, Tools, Capacities
  - Strengthened Planning and Development Management Oversight
  - Justice System Improvements Investigations, Trials, Sentencing, etc.
- Develop an <u>Enforcement</u> Program
  - Reviewing and reporting Investigations
  - Reviewing and reporting Prosecutions
  - Reviewing and reporting Judges Decisions


